The Sustainable Energy Association of Singapore (SEAS), with support from IE Singapore, SPRING Singapore and the Singapore Business Federation (SBF), is leading a Trade Mission to setup a Singapore Pavilion for the 3-in-1 trade show – Renewable Energy Asia, Entech Pollutec, and Pumps & Valves 2011 – which will be held from 1 - 4 June 2011 at BITEC, Bangkok, Thailand.

About Thailand's National Energy Policy

Energy Sufficiency is consistent with His Majesty the King Bhumibol Adulyadej's Sufficiency Economy.

1. To expedite and promote alternative energy. The Thai Government through its 15-Year Renewable Energy Development Plan (REDP) 2008 - 2022 aims to enhance energy security while reducing environmental impact.

2. To effectively save energy and promote energy efficiency. Thailand's Board of Investment has the following supporting schemes & incentives:

- Tax Incentives for Renewable Energy & Energy Efficiency sector
- Technical Assistances
- Investment Grants for Biogas, MSW, Solar sector
- 4 Government Soft Loans

3. To raise Thailand's energy self-reliance. The Energy Conservation Program target is raised from 10.8% to 20%. The total investment of both public and private sectors is estimated to be US\$ 16.1 Billion.
