This workshop will be targeted at building the capabilities of project developers to effectively tailor business plans, identify the right investors and be prepared for effective investment pitches. The financing specialist trainer will work with project developers to refine their plans towards establishing renewable energy projects and securing required investments.

#### **Target Audience**

This specialised workshop is intended for clean-tech entrepreneurs and renewable energy infrastructure project developers who are currently working on a business concept, planning to raise capital for their venture in the near future or expansion capital. This programme is open to both Singapore based companies and overseas participants.
