THE GROWING IMPORTANCE OF RENEWABLE ENERGY

Southeast Asia is now experiencing strong economic growth and the increasing rate of urbanization means even higher energy consumption lies ahead. Thailand's support policies for renewable energy have allowed small projects to flourish, attracting more investment and leading to faster growth in the sector. The government recently introduced its **Alternative Energy Development Plan (AEDP)** the goal of which is for renewable resources to provide 25% of the country's total energy needs by 2022.

THAILAND TO BE DEVELOPED AS ASEAN'S SOLAR HUB...

The government wants to make Thailand ASEAN's hub for biofuel and renewable energy. New policies have already been approved, including packages and initiatives that will further assist in achieving greater energy savings such as...

The revival of private investor **Solar Farm Business** - a policy directive that sets up Solar Farms (ground-mounted solar installations) with a target of 2,000 MW to be reached by 2021.

More Residential Rooftop Capacity - awarded to help meet the 100 MW quota. A target of 200 MW of commercial and residential rooftop systems is the goal.

Solar Community Scheme - The "Solar Community Scheme" was announced last year and is now scheduled to be implemented by the Thai Village Fund in cooperation with the Provincial Electricity Authority (PEA)

PLUS ASEAN'S BIOENERGY HUB...



Biomass - In 2012, Thailand produced 2,000 megawatts from Biomass. According to the AEDP 2012-2021, Thailand aims to produce 3,630 megawatts from Biomass by 2021.



Municipal Solid Waste (MSW) - In 2012, Thailand produced 43 megawatts of power through MSW. Thailand's AEDP aims to produce 160 megawatts from MSW by 2021.



Biogas - The installed capacity of Thai Biogas power plants was 193 megawatts in 2012. AEDP aims for 600 megawatts of biogas utilization by 2021.



Biodiesel and Ethanol - Currently, Ethanol production in Thailand is at 3.89 million liters per day. The consumption of Ethanol is estimated to reach its target of 9 million liters per day by 2021

THAILAND'S 20-YEAR ENERGY EFFICIENCY DEVELOPMENT PLAN: EEDP (2011-2030)

Energy demand in Thailand has been steadily increasing and now depends heavily on energy imports due to limited domestic energy sources. Energy Efficiency (EE) plays an important role in supporting energy security, as well as lowering household expenses and production costs. The EEDP has been designed with the goal of reducing energy intensity - EI (energy consumption/GDP) 25% by 2030 compared to 2010. This is the equivalent of reducing energy consumption 23.5% by 2030 - a potential saving of 38,200 thousand tons of crude oil (ktoe).
